#### AN UPDATE FROM BECKI IN OFFICE

#### REPORT ON 2020 VIRTUAL WISCONSIN ANNUAL UMC CONFERENCE

Pastor Michael and I attended the virtual Wisconsin Annual UMC Conference on Saturday, Oct. 24. The opening ceremony began with a song written and sung by Pastor Jane Sommers, followed by short devotionals by people from different ethnic groups.

Because the conference was condensed from the usual three-day in-person meeting into seven hours, it did not include all the speakers and presentations that are usually offered. Many weeks before the conference, all participants received a 41-page booklet with all the items we would be voting on. During three 90-minute plenary sessions, each of the items was presented by a person who moved its adoption. After seconding, there was time for discussion, then the 515 attendees voted virtually.

Major action items discussed were:

- **1. Joint board resolution related to clergy compensation:** A recommendation that all clergy receive a raise of at least 1.72% was approved by 97.2%.
- **2. Disaffiliation agreement pursuant to the Book of Discipline:** A UMC church that wishes to disaffiliate from the Wisconsin Conference must follow all the rules established in the current Book of Discipline. Any money returned to the conference will be placed in the Pastors' Retirement Fund. Approved by 86.5%.
- 3. Resolutions confirming the discontinuance/closing of local churches: Emerald UMC, St. Croix County; UMC of Alma, Alma, WI; Brandon UMC, Brandon, WI. Approved by 99.6%
- **4. Proposed Conference Budget for 2021:** This item was presented In the morning session, with no discussion. It was the last item to be voted on at the end of the conference. Surprisingly to me, there was very little discussion before approving the \$6,308,190 budget total by 97.1%. The 2020 budget was \$6,376,523.

While the votes were being counted, we saw short, informational videos covering a variety of UMC-funded activities. Zion member Emmett Moroney was part of the group pictured at Pine Lake Camp.

Another interesting video featured the 22 new churches established this year throughout the Wisconsin Conference.

Pastors' years of service, ranging from 25 to 76, were recognized. Rev. Don Fenner, father of Zion members Rev. Bruce Fenner and Caroline Fenner Polster, was honored for 71 years of service.

Abbreviated reports were presented by three task forces that were appointed at the 2019 Conference and have met regularly during the past year. The first task force is working on a vision for the future of the United Methodist Church in Wisconsin.

The second task force is developing recommendations on how the Wisconsin Conference may respond to whatever decisions on the full acceptance of LGBTQ pastors, members, etc., that come out of the next General Conference. This worldwide meeting was scheduled for 2020 in Minneapolis. It was, of course, postponed because of the pandemic, and no new date has been set.

The third task force is working on anti-racism. All of the task forces were to present final reports at the Oct. 24 conference, but because of the pandemic have been given extra time to work on them.
